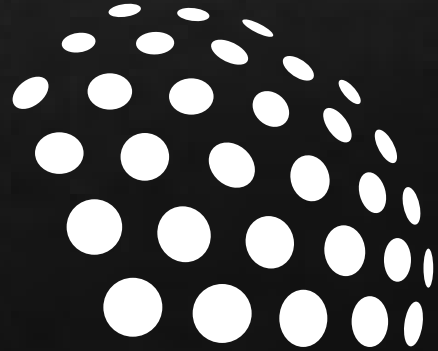

PROFESSOR Mthuli Ncube, a Zimbabwean, is a financial, economics, investment, and public policy expert with vast experience in both the private and public sectors. He was Professor of Public Policy at Blavatnik School, Oxford University, United Kingdom, and HSBC Bank Professor of Finance and Dean at Wits Business School, University of Witwatersrand, South Africa. He began his academic career as Lecturer in Finance at the London School of Economics, United Kingdom.

Prof. Ncube was also Head of global asset allocation strategy and fund manager at Investec Asset Management.

Prof. Mthuli Ncube also served as Vice President and Chief Economist of the African Development Bank Group (AfDB) where he led the strategic thinking within the bank on economic development issues for the entire African continent. He led and guided the development of the Bank's ten (10) year Strategy (2013-2022) and was a member of the senior management team at AfDB.

He has served as Chairman of the Board of the African Economic Research Consortium (AERC) based in Nairobi, Kenya, which has trained more than 4000 economists at Masters and Ph.D level across Africa.

He is an active participant at the World

Economic Forum (WEF).

As Minister of Finance in the last five (5) years, he has turned Zimbabwe into one of the fastest growing economies in the African region post COVID.

He has exercised fiscal prudence by maintaining the budget deficit in Zimbabwe at below 1.5% of GDP over the last five years, and also maintained a current account surplus over the same period. He has introduced innovative electronic transaction taxes and other innovative taxes.

Professor Ncube also launched an offshore financial centre in Victoria Falls and launched a USD Stock Exchange, the Victoria Falls Stock Exchange (VFEX), as a platform for attracting foreign direct investment.

He has extensive experience in the private sector as an investment banker and fund manager. He holds a Ph.D in Economics (Mathematical Finance) from Cambridge University, United Kingdom, and has published numerous books and articles.

Currently, he is in his second term as the Minister of Finance, Economic Development and Investment Promotion in Zimbabwe.

He continues to be a thought-leader on African economic issues.

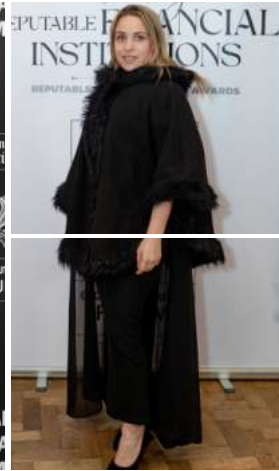

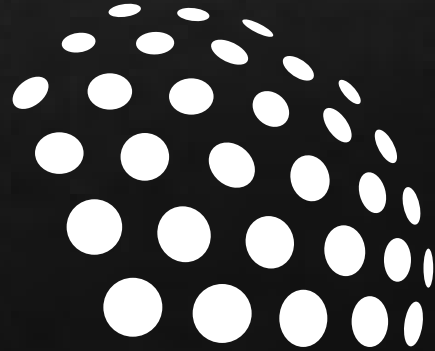

Ameenah Gurib-Fakim served as the first female President of Mauritius from 2015 to 2018, thus making her the third woman to serve as Head of State of the country. She served as the Chairperson for the International Council for Scientific Union – Regional Office for Africa from 2011 to 2014.

In 2016, she was in the Forbes List for the 100 "Most Powerful Women in the World" and 1st among the Top 100 Women in Africa Forbes List 2017, 2019. In 2019, Gurib-Fakim also served as a keynote speaker of Cambridge University's conference "Africa Together: Which Way Forward?"

For her efforts as a scientist, Gurib-Fakim has been recognized worldwide, receiving the L'Oréal-UNESCO Award for Women in Science, Laureate for the National and Economic Council, and the African Union Award for Women in Science.

In 2019, Ameenah Gurib-Fakim received the "Trailblazing Award for Political Leadership" from the World Women Leaders Council in Iceland. In 2022, she serves on the Science Advisory Committee of the Food and Agriculture Organisation, Rome. Council member since 2016.
